Ms Yvonne Chibiya

Ms Yvonne Chibiya is a seasoned development practitioner with over 20 years of experience in Zambia and the southern African sub-region, focusing on governance, human rights, and anti-corruption efforts. She served as Vice Chairperson of the Anti-Corruption Commission of Zambia from July 2020 to 2022, and currently sits on the African Union Advisory Board Against Corruption since May 2023. Yvonne has spent the past decade with Oxfam Zambia, currently holding the position of Country Representative. Her extensive work in the region collaborating organizations like the Human Rights Trust of southern Africa (SAHRIT) and Transparency International Zambia, contributing to initiatives promoting good governance, ethics, and the rule of law.



Dr John-Mary Kauzya

Dr. John-Mary Kauzya, appointed Professor Extraordinary at Stellenbosch University in January 2022, is a renowned Ugandan expert in public governance and administration. After retiring from the UN in 2022 following 22 years as Chief of Public Service Innovation Branch. He continues to advise governments on governance and champion capacity development for innovation in public sector leadership. He holds a PhD in Law from the University of Paris 1 Pantheon Sorbonne. specializing in public administration. Dr. Kauzya has received several prestigious awards, including the O.P DWIVEDI AWARD from IASIA in 2014 and the Braibant Lecture Award from IIAS in 2021, Additionally, he was honored with a Gold Medal by AAPAM in December 2022 for his outstanding contributions to public administration in Africa.



Adv Lavan Gopaul
